#### 4. First-aid measures

#### 5. Fire-fighting measures

#### 6. Accidental release measures

<b>Methods and materials for containment and cleaning up</b>	Eliminate all ignition sources (no smoking, flares, sparks, or flames in immediate area). Keep combustibles (wood, paper, oil, etc.) away from spilled material. Stop the flow of material, if this is without risk. Prevent entry into waterways, sewer, basements or confined areas. Wipe up with absorbent material (e.g. cloth, fleece). Clean surface thoroughly to remove residual contamination.

<b>Precautions for safe handling</b>	Pressurized container: Do not pierce or burn, even after use. Do not use if spray button is missing or defective. Do not cut, weld, solder, drill, grind, or expose containers to heat, flame, sparks, or other sources of ignition. Use caution around energized equipment. 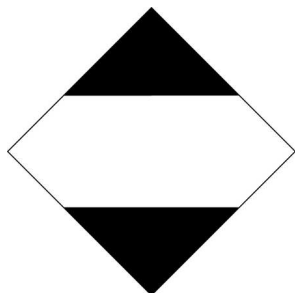

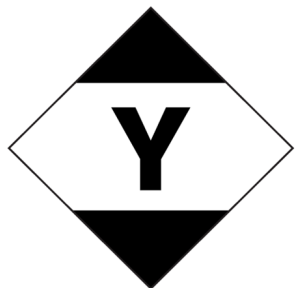
