NAPA's sole obligation and liability for any defect found to exist contrary to this limited warranty in a product sold by NAPA, and purchaser's sole and exclusive remedy for such defect, shall be limited to: (A) NAPA furnishing without additional charge to purchaser, including transportation, a replacement for any of the products sold by NAPA which are found by NAPA to be defective contrary to this limited warranty, and (B) in the case of products which cannot be repaired or replaced by NAPA, NAPA shall credit or refund to purchaser the purchase price paid therefore, provided, that NAPA is advised in writing of such product non-conformance within thirty (30) days of the date of discovery thereof, and that the non-conforming product is returned f.o.b. to NAPA's designated warehouse promptly thereafter, for as long as the consumer owns the automobile, van, SUV, or light truck (less than 8,000 lbs. GVWR) on which the product was originally installed, and only for light duty u-joints in non-commercial service. For all other applications including medium and heavy duty trucks, the warranty period is in any case not later than twelve (12) months from the date of purchase. Valid proof of purchase date/mileage required.
